# VISA PAKISTAN for the Rush Lake Trek (RLT)

All nationalities need a passport with at least 6 months remaining validity at the time of travel and a visa for entry into Pakistan.

WE RECOMMEND UK, US AND EU PASSPORT HOLDERS TO USE THE 'VISA PRIOR TO ARRIVAL' ONLINE APPLICATION

THE VISA IS GRANTED FOR A PERIOD OF 90 DAYS FROM YOUR APPLICATION AND WE RECOMMEND THAT YOU APPLY FOUR TO SIX WEEKS BEFORE YOUR ARRIVAL IN PAKISTAN

This online application process is relatively simple and free of charge. Please note that the process described below is for our Rush Lake (RLT) trip only.

- Pakistani Tour Operator Licence (provided by KE)
- Proof of Islamabad hotel booking (provided by KE)
- Digital scan of the biometric page of your valid passport
- Digital passport-style photograph (see Visa website for exact requirements)
- You MAY be asked to provide 3 months' bank statements and/or proof of address (e.g. utility bill)

Please send a copy of your e-Visa to the KE office once you have received your confirmation.
